TUITION CONTRACT FOR 2017-2018

CONTRACT

I hereby apply for admission for my child, _____ to Cinquegranelli Montessori for the school year 2017-2018. I agree to pay the school the tuition for the year in the amount of **10 monthly payments of \$875 per month**. (Note: pre-school tuitions can qualify for Child and Dependent Care Expense Credit.)

PAYMENT PLAN

Program	10 Monthly Payments
Tuesday – Friday (9:00 AM to 12:00 PM)	\$875 per month

- Each monthly payment is due the first day of the month (e.g. September tuition is due September 1st, October tuition is due October 1st).

- Tuition is an annual fee, unrelated to the number of school days in a given month. No payment adjustments will be made for vacation days, holidays or absences. This full-year approach ensures a well-run program for your child.

NON-REFUNDABLE FEES

New Student Registration Fee	\$150	For each new enrollment to Cinquegranelli. This fee covers our slow start program, beginning August 30 th . Fee due upon submission of the application form.
Returning Student Registration Fee:	\$125	For returning students to hold their space in Cinquegranelli. This fee is due upon submission of the application form.
Annual Materials and Activity Fee:	\$175	For each student. Due September 1 st , 2017.

OTHER FEES

Late Tuition Fee: \$25 will be charged for payments received after the 5th of the month.

Late Pick-up Fees: \$10 will be charged if a child is not picked up within 10 minutes of their dismissal.

Returned Checks: \$35 will be charged.

EARLY WITHDRAWAL/CONTRACT TERMINATION

Cinquegranelli Montessori reserves the right to terminate the Contract if the Teacher and Director determine that the student is or will be unable to thrive in this school environment. This action will occur only after attempting to resolve any problems that exist. If the Contract is terminated by the school under these circumstances, tuition will be pro-rated.

WITHDRAWAL BY THE PARENT(S)/GUARDIAN(S)

In order to maintain budget stability in a small school, tuition for Cinquegranelli is a full year requirement. In other words, a family electing to withdraw their student before the school year is over, is required to pay tuition for the remainder of the school year. Although individual circumstances will be reviewed, the tuition will not be refunded or forgiven unless or until Cinquegranelli is able to fill the open student spot created by the withdrawal.

I Agree to 10 Monthly Payments of \$875 (due on the 1st of each month)

This is a 10-month contract consisting of 10 payments of \$875 due on the first day of each month. Should a family under this plan wish to withdraw their student before the school year is over, the family is expected to continue paying \$875 monthly until Cinquegranelli Montessori is able to fill the open student spot created by the withdrawal. One solution is to connect us with a replacement student.
